TERMS AND CONDITIONS OF AGREEMENT

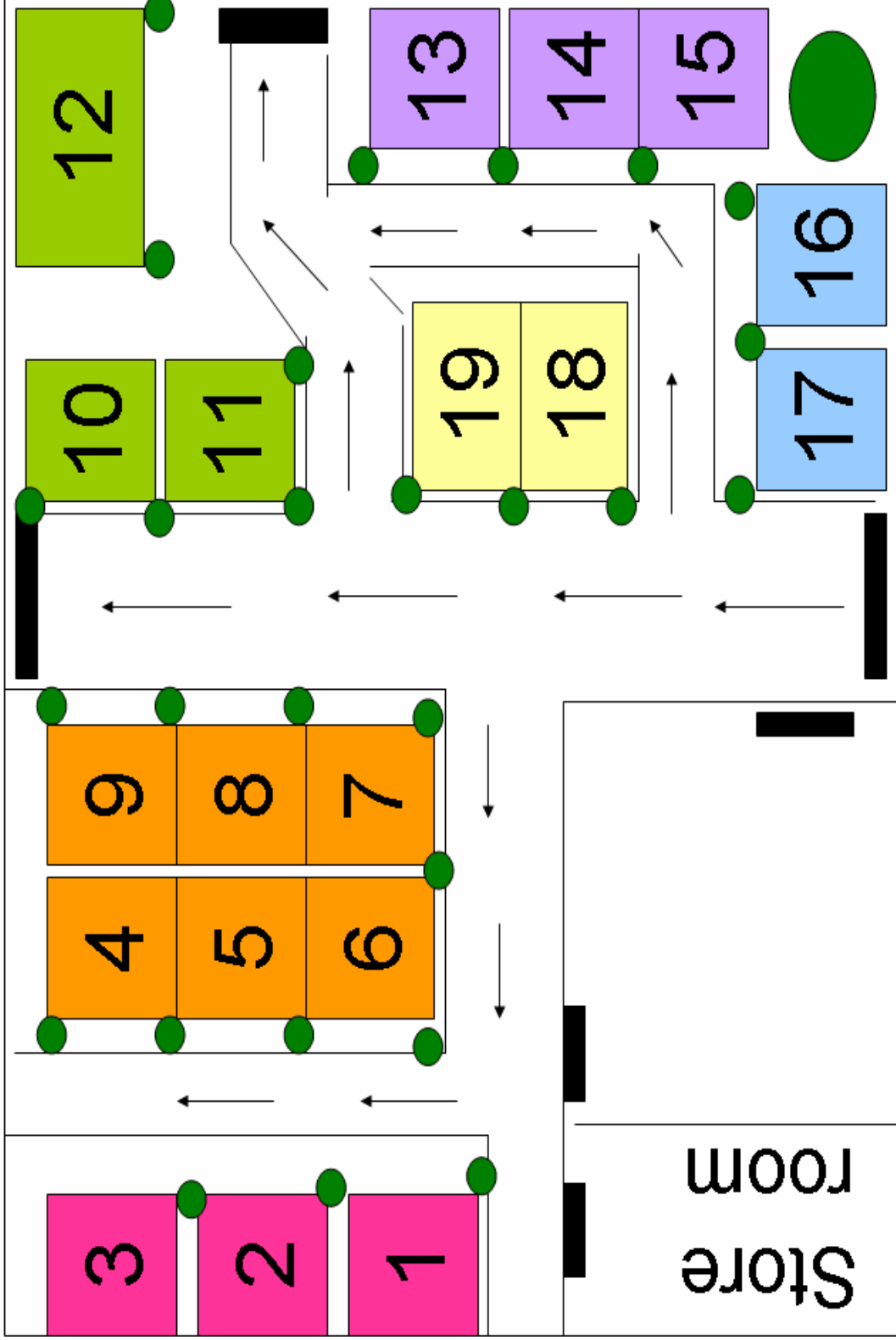
1. In these conditions the term "Exhibitor" means the signatory of this application and includes all employees and agents of such. The "Organiser" means the Zululand Christmas Festival 2010 committee.
2. Upon acceptance of the Exhibitor's Application Form, a contract shall arise between the Organiser and the Exhibitor in terms of these conditions.
3. Stands will be considered booked on receiving full payment for a stand. **NB: NO PAYMENTS WILL BE REFUNDED. FULL PAYMENT MUST BE RECEIVED** to secure the stand allocated to the exhibitor.
4. If an exhibitor fails to pay the contract price at the prescribed time the organisers reserve the right to cancel the booking.
5. In this event, or if the Exhibitor cancels the booking after payment of stand, the payment will be forfeited. **THERE WILL BE NO EXCEPTIONS TO THIS RULE.**
6. The Organiser shall have full power to determine in every respect the allocation of area and position of space and shall be entitled to vary the general layout, or the situation, or area of any particular stand even if already allotted.
7. The Exhibitor shall accept a new allotment of space in substitution of that originally allotted.
8. The Organiser or sponsors shall be indemnified by the Exhibitor against any claim or action on account of any injury or damage by an exhibit to any persons whatsoever.
9. All stands and their exhibits must be completed in time as prescribed by the Organisers and must be in good order and well displayed during the hours the Festival is open to the public. No removal or dismantling may commence before the closing time on the last day.
10. The Organisers reserve the right to disbar an exhibitor from attending future shows should they not conform to the terms of these conditions.
11. Where space is booked, but not occupied by the Exhibitor at the time of opening, for any reason whatsoever, there will be no refund of payment made and moreover the Organiser may re-allocate the space immediately.
12. The Exhibitor will be responsible for the cost of restoring to its original condition any part of the land or structure occupied by the exhibitor which has been altered or damaged in any way.
13. Neither the Organisers, ZCBF or any sponsor or company associated with the Zululand Christmas Festival will be responsible for the safety of any exhibit or property of any Exhibitor or any person, for the loss or damage of or destruction to the same by theft or fire, power failure or whatsoever, or for any loss or damage sustained by the Exhibitor by reason of any effect in the buildings or marquees caused by fire, storm, tempest, lightning, national emergency, war, labour unrest, strikes, explosions, Act of God etc., or any cause not within the control of the Organiser.
14. In no event shall the Exhibitor have any claim of any kind against the Festival, ZCBF, sponsors or associated companies, in respect of any loss or damage consequential upon the prevention, postponement or abandonment of the Festival, by reason of the happenings of any event referred to in Condition 11, or of the show grounds becoming wholly or partially unavailable for the holding of the Festival for reasons beyond the Organiser's control.
15. The Organiser shall be entitled to retain such parts of the sum paid by the Exhibitor as the Organiser considers necessary. If, in the opinion of the Organiser, by re-arrangement of the date of the Festival or by substitution of another building or marquee, the Festival can be carried out, the contract for the space shall be binding upon the parties, except as to size and positions of stands, as to which any modification, substitution or re-arrangement it considers necessary shall be determined by the Organiser.
16. In the event of a breach of any of the conditions herein the Organiser may in all cases retain all monies paid by the Exhibitor and recover further monies from the Exhibitor as provided herein.
17. The Organisers reserve the right to remove any vehicles illegally parked on the ground. The exhibitors will have an allocated parking area in which all vehicles can be parked unless otherwise arranged with the Organisers.
18. Furthermore, neither the towing company or the organisers will be held responsible for any damage caused to towed vehicles.
19. All electrical appliances in use during the duration of the show will at all times be in good working order. Should any appliances be faulty and cause interferences or interruptions in the power supply or inconvenience other exhibitors in any way, the faulty equipment will be removed by the Organiser.
20. **Electricity will only be provided for exhibitors who have requested power** (booked before the show and not during the show).
21. Exhibitors are to remove their goods after the completion of the show.
22. Festival organisers reserve the right to move any stands or entrances for logistical purposes or at organisers' discretion for safety and security reasons.
23. Right of admission reserved by the Festival officials at any time.
24. Participation entirely at own risk.
25. Management reserves the right to limit the number of exhibitors.
26. The organisers will not take responsibility for any power cuts or load shedding that occurs during build-up or show days. No exhibitor may dismantle their stand before the close of gates on the last day of the show.

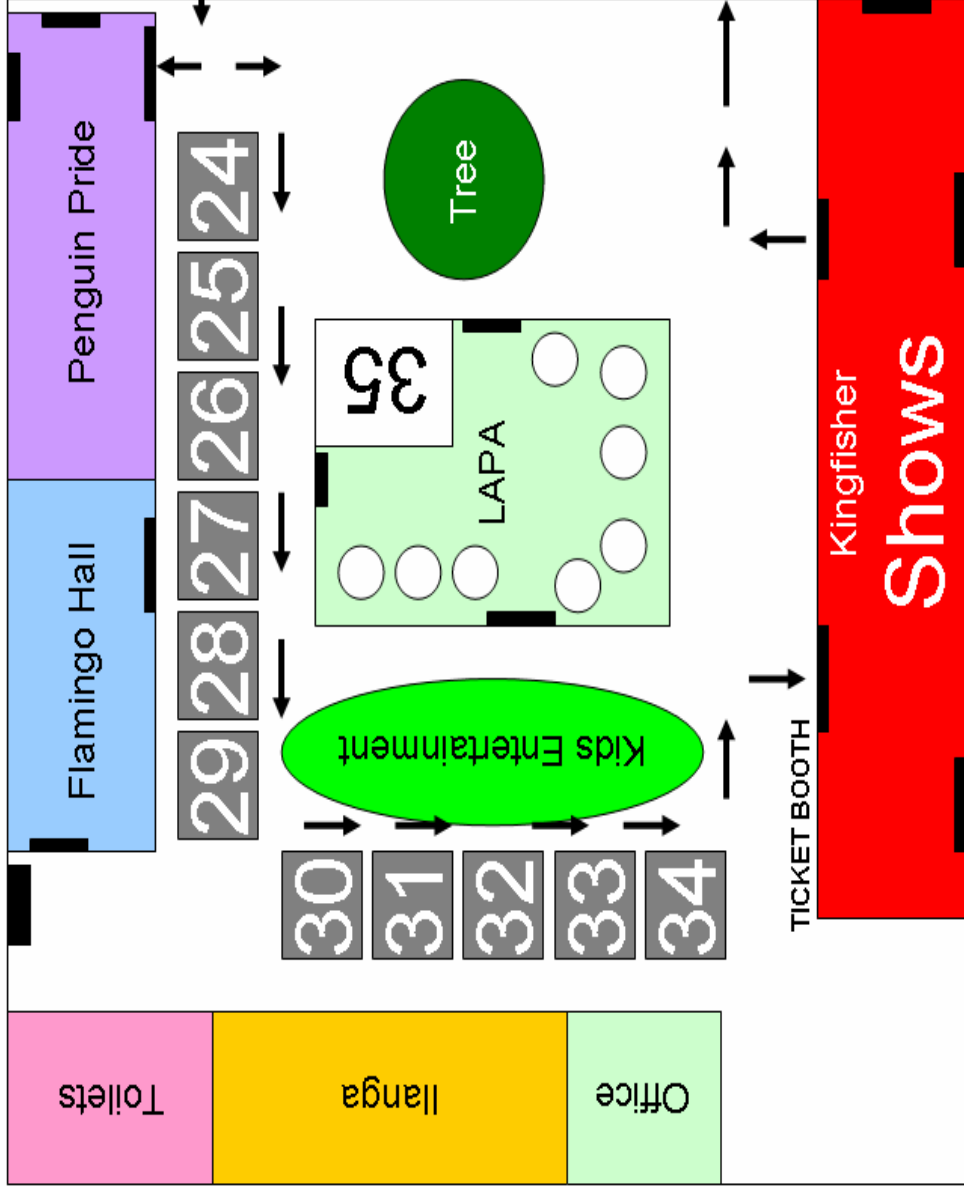
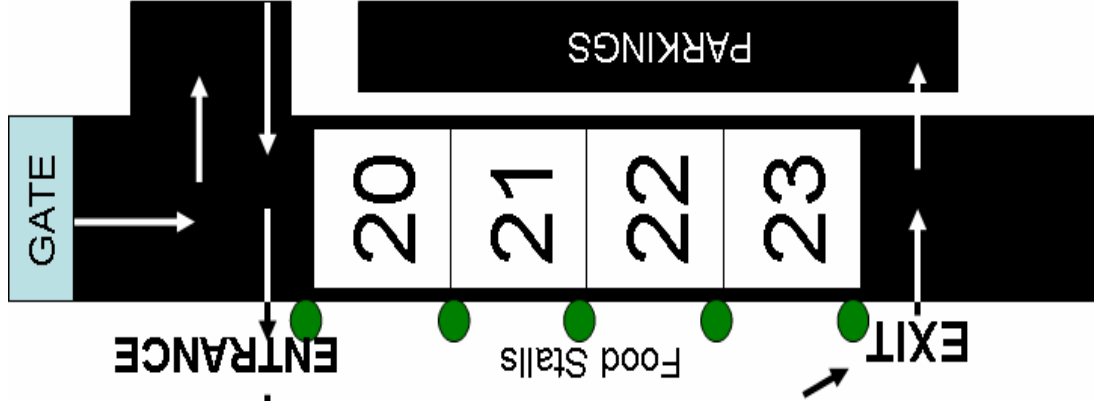
